Tuition for TJ's week at camp was provided by the Debra Bell Levesque Scholarship Fund established in memory of a former Conservation Commission member. It is supported by donations and by sales of the Conservation Commission Calendar. The camp is operated by NH Fish and Game in partnership with 4-H through UNH Cooperative Extension. The camp scholarship recipient is chosen from entries submitted by interested students. We encourage all Candia students between the ages of 10 and 16, who like the outdoors, to consider applying for the 2019 scholarship. ANONYMOUS EASEMENT DONATED

An anonymous donor family has made a major contribution to protecting some of Candia's natural resources. They have donated an easement on over 100 acres abutting other conserved land which helps protect the headwaters of the Lamprey River. These parcels in turn lie in an unfragmented block of undeveloped land that extends to Bear Brook State Park and totals more than 20,000 acres! The block includes areas of highest ranked habitat, according to the NH Wildlife Action Plan, and shelters endangered wildlife species which rely on these habitats. A local land trust will hold the easement. The transaction costs were funded entirely by grants and no cost was incurred by Candia.

The Commission extends its sincere thanks to the family for their generosity and concern for the future of Candia's natural resources.


IS CLIMATE CHANGE REAL?

A Note From The Chair...

Recently, while speaking about potential conservation projects, I was asked "What value is there for us in protecting this land?" What a challenging question to answer, given we are not able to see all the benefits of the land around us. Nearly seventy years ago this question was being wrestled with by Aldo Leopold in his 1949 essay "Land Ethic". Consider his quote:

A system of conservation based solely on economic selfinterest is hopelessly lopsided. It tends to ignore, and thus eventually to eliminate, many elements in the land community that lack commercial value, but are essential to its healthy functioning - Land Ethic

Often, we do not realize the economic benefit of land and or species until they are lost. However, when we neglect to consider the value of forests and wetlands and convert them for development, we may be weakening our defense of a healthy functioning land community, such as was evident this fall in the wake of the 2017 hurricane season. But there is still hope and there are ways to develop and at the same

time plan to protect the natural resources we rely upon. It requires a joint effort of various groups to assess the available resources and develop wisely with our neighbors in mind.
